Regarding 15% of income of Temple Trust to be used for Gaushalas in Himachal Pradesh under section 22 (g) of H.P. Hindu Public Religious Institutions and Charitable Endowment Act, 1984 (as amended up to 2018).

Sir,

On the subject cited above I am directed to say that the Commissioner (Temple) -cum-Deputy Commissioners up the above statutory provision are hereby authorized till further orders to allocate need basis funds from the 15% of income of Scheduled Temple Trust earmarked for the Gaushalas of the temples. If such temple in your district is not running its own Gaushala then this fund could be allocated for use by Gaushalas run by registered NGOs in the vicinity of the scheduled temple(s) in the district. Unused balance, if any out of this 15 % can be given as grant to other eligible registered Gaushalas in the districts after verifying the need and after government approval.

This process may be initiated and the progress/ compliance be sent to the Chief Commissioner (Temple)-cum-Secretary (LAC) to the Government of H.P. and Gau Sambardhan Board within a month for information and further necessary action.

Sir,

The above amendment provides as follows ; 22 (g) "fifteen percent of the receipt of the Hindu Public Religious Institutions and Charitable endowment shall be utilized as first charge for construction, maintenance and up-gradation of gau- sadans or for Gau vansh samvardhan" among the scheduled Temples there are some that have very low income. On the subject cited above I am directed to say that the Commissioner (Temple) -cum-Deputy Commissioners are requested to give their suggestions/ comments whether 15% of income of all affluent Temple Trusts in Himachal Pradesh should be pooled so that it can be reallocated to cater to gaushalas run by temples having very low income. Your comments may kindly be sent in 15 days for further consideration to frame a policy on this subject.
